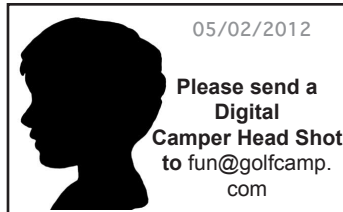

FEES INCLUDE

Tuition Includes: greens fees, meals, room & board, medical first aid attention (not including medicine, prescriptions, doctor or hospital visits, medical treatment, operations or procedures, x-rays, or anything that can not be handled by our nurse on duty), and trips such as lobster feasts, mountain hiking, rock climbing, whale watching and planned camp activities (if enrolled by April 30th). Fees are based on the number of weeks of attendance **and** the date we receive your deposit. In order to reserve space for your camper and qualify for any enrollment discounts we must receive a deposit of \$2,000.00 per camper along with this Application **and** payments must be received by the scheduled dates below. **Late payments nullify all discounts.** All fees must be paid in full before campers will be permitted to attend camp.

GENERAL INFORMATION

All campers must have adequate medical insurance to cover all medical expenses incurred while at camp. Proof of Medical Insurance and a Physical Exam are required annually. Maine Golf Academy, its owners and directors, reserve the right to dismiss for cause any camper whose conduct or influence is unlawful, in violation of camp policy, or is deemed unsatisfactory to the camp community. In such event there will be no reduction or refund of camp fees. Maine Golf Academy, its owners and directors, reserve the right to use any individual or group photographs, video, digital, and/or audio recordings taken at Camp and elsewhere documenting campers in activities for camp publicity and public relations purposes, including publication on the MGTA web site, both now and in the future.

REFUND POLICY: All Fees Include a NON REFUNDABLE Administrative Fee

Withdrawal or change in arrangements of any kind must be submitted in writing and received before April 30th. Refunds for payments made will be issued in full, less the **\$600 Administrative Fee** if the request is received in writing before January 1st. Refunds for payments made will be issued in full, less the **\$1,000 Administrative Fee**, if the request is received in writing before April 30th. No refunds, reductions, allowances, or credits against fees paid or due will be made after April 30th for any reason, including cancellation, late arrival, early withdrawal, or dismissal of camper. Any and all Refunds will be issued on or about April 30th. Campers that convert from one length session to another will pay fees quoted at the time of the change and forfeit all early enrollment discounts. The undersigned agrees not to charge back any amount on any and all credit card payments. **Cancellation Insurance is available through www.mycampprotector.com.**
